Dear Mare Owners,

First of all I want to thank you for breeding to one of my stallions, I so appreciate your belief in my program. Just a few things to consider for success. You need to start early in the season, when there is the most semen available and you can work with your veterinarian to make sure your mare can—and is ready to—conceive. As always, I will do my best to help you and your vet get your mare in foal.

Remember rebreeds are only good for one year after the original contract (rebreed fee is \$500 plus \$400 shipping). I will make one exception the following year, but mare must at my place so I can use fresh semen. **Breedings purchased through stallion incentive auctions are only good for the year they were purchased.** Please be diligent about getting your mare ready. Also, this may be the time to reconsider whether you will have success and if not, you might consider breeding another mare instead. Again the earlier you start the process the more likely you will have a foal.

I look forward to working closely with you on this exciting adventure.

- 1] Signed contract must be returned to Jill Lane Quarter Horses with a copy of mare's registration papers, front and back, and entire stud fee, prior to each shipment of semen.
- 2] **A transported semen fee of \$400 must be paid to Jill Lane Quarter Horses prior to shipment of semen via FedEx.** The transported semen fee includes cost of collection, processing, Equitainer and shipping. These fees are subject to increase due to fuel surcharge. **JLQH is not responsible for shipping fees if FedEx can't deliver on time, including because of bad weather. If you are concerned about this you should consider frozen semen.**
- 3] A deposit is not required on the Equitainer. Mare Owner agrees to return Equitainer and all shipping materials to Jill Lane Quarter Horses within one week. If Equitainer is not returned, a \$300 fee will be charged. **Return costs for shipping Equitainer to Jill Lane Quarter Horses must be paid by the Mare Owner.**
- 4] Mares on premises of Jill Lane Quarter Horses have a breeding priority on any given breeding day. Therefore, Jill Lane Quarter Horses makes no guarantee that cooled semen will be available for transportation. **We collect only Mondays, Wednesdays and Fridays and need to know by 8am the day of collection days to ship semen.** Available semen will be on a first-come first-served basis. We guarantee one breeding dose, we will send two if available.
- 5] The receiving veterinarian/farm manager and the shipping location named below shall be agreed to as a part of this contract:

- 6] Jill Lane Quarter Horses will collect the stallion Monday, Wednesday and Friday during the breeding season. No guarantee of delivery within a certain time period nor the quality of the semen at arrival is given. Jill Lane Quarter Horses is not liable for damages during shipment or if the mare doesn't settle.
- 7] The mare owner represents the mare is healthy and in sound breeding condition and registered with the designated registration organization.
- 8] Live foal guarantee by stallion owner is contained herein with return privilege for the year immediately following. "Live foal" means that the foal resulting from the breeding stands alone, nurses, and lives for 24 hours. If foal is born dead or dies within 24 hours this guarantee only applies if the mare owner a) notifies stallion owner within 72 hours after the time of foaling that the mare did not produce a live foal and b) within ten days after the mare owner's notice, the mare owner provides the stallion owner with a statement from a licensed veterinarian giving the particulars required to substantiate the failure of mare to produce a live foal. A replacement mare may be substituted at the stallion owner's discretion if the mare named in this contract is unsuitable for a rebreed. **Rebreeds are only good for the year immediately following the original contract season (although I will make one exception for the next year if the mare is at my place so we can use fresh semen). Breedings purchased through stallion incentive auctions are only good for the year they were purchased.**
- 9] It is understood that should this stallion die or become unfit for service, this contract shall become null and void and the stud fee less the booking fee shall be refunded to the mare owner.
- 10] Each additional shipment will incur another shipping fee, with a limit of three (3) shipments per breeding season, per mare.
- 11] A breeder's certificate will be issued by the stallion owner for each live foal born as a result of breeding services herein provided. All fees and expenses pertaining to this breeding must be paid in full prior to issuance of certificate.

## COOLED TRANSPORTED SEMEN ADDENDUM

Some suggestions to help us provide the best possible Cooled Transported Semen (CTS) service for this breeding season:

- 1.** Contract Stallion Service Fee Balance must be paid in full prior to ordering first semen shipment. Stallion fees purchased through stallion incentive programs may only breed the year the stallion fee is purchased. Rebreeds are only available the year immediately following the original contract season.
- 2.** Signed and fully executed contracts, copy of mare's registration papers and signed Cooled Transported Semen Addendum must be on file at Jill Lane Quarter Horses prior to first shipment. We accept Visa and MasterCard and Paypal (friends and family to JillLane@3rivers.net)
- 3.** First Shipment Fee must be paid prior to first shipment, Jill Lane Quarter Horses will be responsible for costs incurred including courier from Jill Lane Quarter Horses via Fed Ex. Jill Lane Quarter Horses is not responsible for any courier charges at the receiving end. Each additional shipment will incur another shipping fee, with a limit of three (3) shipments per breeding season, per mare.
- 4.** We do not charge a deposit on shipping containers however we ask that the Equitainer and all internal shipping parts must be returned at mare owners' expense immediately following insemination of the mare. Mare owner agrees to reimburse value of any shipping container or parts that are not promptly returned. Please return Equitainer by Fed Ex or UPS so that you have tracking information in the case of missing parts. Any Equitainer not returned within one week of shipping date may be charged a fee of \$25/day if the delay is a result of neglect to return.
- 5.** Semen will be collected and shipped on breeding days—Mondays, Wednesdays and Fridays—only.
- 6.** Mares on the premises of Jill Lane Quarter Horses have breeding priority on any given breeding day; therefore we make no guarantee cooled semen will be available for a specific day.
- 7.** A request for shipment of cooled transported semen must be made no later than 8am day of collection. Cancellation of shipment must be made prior to 8am on the day of shipment or the shipping fee will be charged. (We collect the stallion, package semen and have courier service arranged by 8:30am on breeding days.)
- 8.** Please have your vet stay in contact with us as they follow your mare through her heat cycle and report her palpation/ultrasound checks to us. This will help us manage and coordinate CTS shipments. Do not wait until the day before the mare is ovulating to contact us for a shipment.
- 9.** Please inform us of your mare's ovulation date and results of pregnancy checks as available for our records.
- 10.** The key to breeding your mare with cooled transported semen is very careful planning, experienced reproductive mare management and conscientious communication and coordination with the Stallion Owner.
